- 6. AED Lycoming County received grant for purchasing AEDs and would like to put them in outlying areas of the county. It would be free to the township. Joe made a motion, seconded by Steve, to accept this. Some discussion insued as to just where to put this, on the outside of the township building so to be accessible by the public.
- 7. County wide Action Plan Secretary had provided copy to the Board.
- 8. Small Games of Chance Joe made a motion, seconded by Dave, to have this question put on the ballot for May.
